

Subject: Equivalence of Degrees awarded by Open and Distance Learning  
(ODL) Institutions at par with Conventional Universities/ Institutions

Sir/Madam,

There are a number of Open and Distance Learning Institutions (ODLs) in the country offering Degree/ Diploma/Certificate programmes through the mode of non formal education. These comprise Open Universities, Distance Education Institutions (either single mode or dual mode) of Central Universities, State Universities, Deemed to be Universities, Institutions of National Importance or any other Institution of Higher learning recognized by Central/State/Statutory Council/Societies registered under the Society Registration Act 1860.

2. A circular was earlier issued vide UGC letter F1 No- 52/2000(CPP-II) dated May 05, 2004 (copy enclosed) mentioning that Degrees/Diplomas/Certificates/awarded by the Open Universities in conformity with the UGC notification of degrees be treated as equivalent to corresponding awards of the traditional Universities in the country.

3. Attention is also invited to UGC circular No F1-25/93(CPP-II) dated 28th July 1993 (copy enclosed) for recognition of degrees and diplomas as well as transfer of credit for courses successfully completed by students between the two types of universities so that the mobility of students from Open University stream to traditional universities/institutions is ensured without any difficulty.

4. The Government of India, in exercise of its power conferred under section 20(1) of UGC Act 1956, issued directions dated 29th December 2012 entrusting UGC with the responsibility of regulating higher education programme in open and distance learning (ODL) mode. Consequently, Universities/ Institutions desirous of offering any programme through distance mode would require recognition of UGC.

**Subject:- Revision of the scheme of "Vocationalisation of Higher Secondary Education".**

It is to inform that the Centrally Sponsored Scheme of "Vocationalisation of Higher Secondary Education" has been revised and henceforth will be known by the name of "Vocationalisation of Secondary and Higher Secondary Education". The Scheme has already been subsumed under the Rashtriya Madhyamik Shiksha Abhiyan scheme with effect from 1st April, 2013.

The major changes in the scheme are as follows:-

- i) Introduction of Vocational Education from Class IXth onwards i.e. at the secondary stage.
- ii) 75:25 sharing pattern between Center and States for funds released under all the components of the scheme. 90:10 sharing pattern for funds released to the North Eastern States including Sikkim.
- iii) Provision for a flexible pool of Rs. 14.50 lakhs per annum per school for engaging resource persons including Teachers/Skill Knowledge Providers/Trainers etc.
- iv) Provision of financial costs for engaging with the Industry/Sector Skill Councils (SSCs) for assessment, certification and training.
- v) Enhancement of funds for purchase of books and e-learning material.
- vi) Financial provision (1% of total budgetary outlay) for Innovative Programmes under vocational education.
- vii) Cost of development of curriculum and learning materials to be a maximum of Rs. 2.00 lakhs per skill level per job role.
- viii) Performance linked incentive to Govt. aided and recognized, unaided private schools.

**Subject:** Guidelines under section 35(1) of the Right of Children to Free and Compulsory Education Act, 2009 regarding procedure for admission in schools under section 13(1) and section 12(1)(c) of the RTE Act - regarding.

Section 13(1) of the Right of Children to Free and Compulsory Education (RTE) Act, 2009 provides, inter-alia, that while admitting a child, no school or person shall subject the child or his/her parents to any 'screening procedure' Section 2(o) of the RTE Act defines the term 'screening procedure' to mean the 'method of selection for admission of a child, in preference over another other than a random method' Further, section 12(1)(c) of the Act provides that unaided schools and specified category schools shall admit at least 25% of the strength of class I, children belonging to weaker section and children belonging to disadvantaged group from the neighborhood and provide them free and compulsory education till completion of elementary education. Further, where the school admits children at pre-primary level, such admissions shall be made at that level.

2. The Ministry has received representations from several unaided and aided schools seeking clarification on the procedure to be followed for admission. The Ministry held a meeting with various stakeholders on the 14th August, 2010 to elicit their views for formulating a guideline for admissions, which would be consistent with the spirit of the RTE Act, specifically with section 13(1) read with section 2(o) of the Act.

3. The objective of the provisions of section 13(1) read with section 2(o) is to ensure that schools adopt an admission procedure which is non-discriminatory, rational and transparent, and that schools do not subject children and their parents to admission tests and interviews in order to decide whether they will admit a child or not. Admission tests and interviews are generally a tool for profiling and eliminating children, and therefore screening to assess a child's 'intelligence' should be prohibited. The RTE Act is anchored in the belief that availability of equal educational opportunities to children belonging to different social and economic background will reinforce the idea of equality enshrined in our Constitution, and ensure that children are not discriminated on the basis of social or economic background or any such criteria. There is need for moving towards composite classrooms with children from

deverse background, rather than homogenous and exclusivist schools. It is on academically established point that heterogeneity in the classroom leads to greater creavity.

4. Keeping these objectives in view, the following guidelines are issued under section 35(1) of the RTE Act, 2009.

- (i) with regard to admissions in class I (or pre-primary class as the case may be) under section 12(1)(c) of the RTE Act in unaided and 'specified category' schools, schools shall follow a system of random selection out of the applications received from children belonging to disadvantaged groups and weaker sections for filling the pre-determined number of seats in that class, which should be not less than 25% of the strength of the class.
- (ii) For admission to the remaining 75% of the seats (or a lesser percentage depending upon the umber of seats fixed by the school for admission under section 12(1)(c), in respect of unaided schools and specified category schools, and for all the seats in the aided schools, each school should formulate a policy under which admissions are to take place. This policy should include criteria for categorization of applicants in terms of the objectives of the school on a rational, reasonable and just basis. There shall be no profiling of the child based on parental educational qualifications. The policy should be placed by the school in the public domain, given wide publicity and explicitly stated in the school prospectus. There shall be no testing and interviews for any child/parent falling within or outside the categories, and selection would be on a random basis. Admission should be made strictly on this basis.

5. The aforementioned guideline should be brought to the knowledge or all concerned for necessary compliance.

संस्थान में शिक्षा पा रहे देश के गरीब, बेसहारा, विकलांग आदि छात्रों को संस्थान ने अपने विद्यालयों में निःशुल्क शिक्षा एवं छात्रावास एवं पुष्टाहार (मोजन) की व्यवस्था की है। संस्थान से एकेडमिक शिक्षा पा चुके छात्र जो आपके विश्वविद्यालय एवं विश्वविद्यालय के महाविद्यालयों में प्रवेश चाहते हैं जो विश्वविद्यालय के आस-पास के ही रहने वाले हैं यदि उपरोक्त विषयक सम्बन्धित पत्र जल्द नहीं मिल पाता है तो उन्हें उच्च शिक्षा से वंचित रहना पड़ सकता है जो उचित नहीं है।
